RE: Nomination of Gordon MacDonald for New Hampshire Attorney General

Dear Governor Sununu:

I just read where you have nominated Nixon Peabody Attorney Gordon MacDonald to be the next Attorney General for New Hampshire. Governor's Executive Council is to meet on the nomination April 5, 2017. If there are no objections and Executive Council agrees to the nomination, then as I understand the law, Gordon MacDonald will be the Attorney General for the State of New Hampshire.

I have taken the time to read Attorney MacDonald's on-line bio. What caught my interest was that he clerked for Judge Norman Stahl while he served on the First Circuit Court of Appeals. I also read that Attorney MacDonald stated that he would recuse himself on issues where there are conflicts. I believe that I am one of those conflicts.

By now you must be familiar with the history of my family's criminal complaints that also involve Public Corruption of certain New Hampshire agents and its Officer's of the Court. I know that you are aware that Attorney Norman Stahl, formerly Devine Millimet Stahl & Branch was appointed to the bench by President HW Bush 41, on whose behalf your father served as Chief of Staff. This was at the time of my family's very first criminal complaints against Devine Millimet and Attorney Shah and his protégé Karen McGinley. Believe it! This issue is still alive today, and is currently in front of the NH Office of Attorney General, and the US DOJ, Criminal Division. The referral to the US DOJ Criminal Division was made by its Office of Inspector General in August 2015. A subsequent referral has been made by KY Senator Rand Paul. And, since the

issue has been outstanding since 1989, even your brother, the Senator, has had his hands full of it.

The point I am making is that Gordon MacDonald has been with Nixon Peabody since 1995. Nixon Peabody Attorneys have knowledge and information that would make them witnesses, or defendants in the issues relating to FDIC and the failure of BankEast. I know this because at one time Mr. Kent Martling brought me to meet with Attorney Nixon, and as soon as he heard the subject matter he ushered us out of his office citing conflicts.

So, in order to save time, and barring any unforeseen events, I have made the assumption that Attorney MacDonald will be the NH Attorney General after April 5, 2017. Therefore, I would implore you to immediately appoint an independent counsel to review my situation, particularly the State v Jean Allan, Laconia District Court (09) which is essentially on hold until the issue of my legal competency can be evaluated.

I have made this request to other NH Governors, and I have been denied. In November 2013, Attorney General Joseph Foster again denied my request for reevaluation. I am cautiously optimistic that you will find a way that will allow me to raise my affirmative defenses to the charges of criminal trespass. The main document that is material to the criminal trespass and foreclosure matter is the October 12, 1989 forged document that was created by Attorney Norman Stahl and his protégé Karen McGinley in cahoots with Attorney Bill Shaheen's Law Office, and Attorney Daniel Sklar who is a partner in Nixon Peabody. The damage model for a RICO case will be in the multi millions of dollars.

Lives are at stake in my request. Today is the 16 Anniversary of the Black Hearted killing of my Mother Agnes Sovik Allan. Her body was on the way to NH Office of Medical Examiner in the custody of NH Agent Kelly Ayotte. Her body has been missing to her family since that day. The autopsy report that was given to me years later was not my Mother. Her killers have never been brought to JUSTICE.

In Conclusion, Governor Sununu, do you have the political will to finally put this miscarriage of JUSTICE to rest? Or, will you soon own it? I can be reached at the above addresses. Currently, I am out of the country visiting with family, but if necessary and with a guaranty of protection, I can make myself available for a debriefing, and or reevaluation.
